

# NIST FIPS 201-2 Approved Identity Documents for HSPD-12 PIV Issuance

(I-9 employment verification form does not apply for PIV Enrollment or Issuance)

**Please note that in order to receive the badge the applicant will need to provide two current forms of identity source documents in original form, one must have a current photo.**

The primary identity **source document shall be neither expired nor cancelled**, must be one of the following forms of identification:

- U.S. Passport or a U.S. Passport Card
- Permanent Resident Card or Alien Registration Receipt Card (Form I-551)
- Foreign Passport that contains a temporary I-551 stamp or temporary I-551 printed notation on a machine-readable immigrant visa
- Employment Authorization document that contains a photograph (Form I-766)
- Driver's License or an ID Card issued by a state or possession of the United States provided it contains a photograph
- U.S. Military ID Card
- U.S. Military dependent's ID Card
- Department of Defense Common Access Card
- Unexpired HSPD-12 PIV ID

## **RLA Only**

- In the case of a nonimmigrant alien authorized to work for a specific employer incident to status, a foreign passport with Form I-94 or Form I-94A bearing the same name as the passport and containing an endorsement has not yet expired and the proposed employment is not in conflict with any restrictions or limitations identified on the form
- Passport from the Federal States of Micronesia (FSM) or the Republic of the Marshall Islands (RMI) with Form I-94 or Form I-94A indicating nonimmigrant admission under the Compact of Free Association Between the US and the FSM or RMI
